- 5. Sealed Quotation will be publicly opened in the presence of the bidder's designated representatives and anyone who choose to attend at the MRM at 14:00 Hrs On 29 Jestha 2075. Quotations must be valid for 30 days counting from the day of bid opening and must be accompanied by bid security, amounting maintained above.
